"H. CERTIFIED ARBORIST/IDOA COMPLIANCE An Arborist certified by the International Society of Arboriculture must be on the job site at all times. Their name(s) and certification number(s) shall be included in the bid document. Failure to have a certified arborist on site at all times may result in termination of the contract at the discretion of the Village..."
